



Citi Cards & Union Power New Sign Up Promotion - Terms and Conditions

1. The Promotion commences on 8 July 2020 and ends on 31 August 2020, both days inclusive ("Promotion Period").
2. Only Citi Credit Card Cardholders (excluding Corporate/Commercial Cards) with a registered residential address with postal code starting from 01 to 83, who sign up for any Union Power residential electricity price plan below ("Promo Price Plan") during the Promotion Period are eligible to participate in this Promotion ("Eligible Cardholder").
3. Under the Promotion, an Eligible Cardholder will receive below one-time bill rebate (the "Gift") if he/she fulfills all of the following, during the Promotion Period:
 - (a) is among the first 250 new Union Power customers to apply the Promo Code to sign up for the respective Price Plans in accordance with the table below; and
 - (b) successfully sets up a recurring bill arrangement with his/her Citi Credit Card; and
 - (c) charges to his/her Citi Credit Card the first recurring Union Power electricity bill by 31 October 2020; and
 - (d) is not a United States ("U.S.") Citizen, U.S. Resident, or U.S. Green Card holder. A person is a "U.S. Resident" if he is present in the U.S. for more than 31 days in the current calendar year, and for an average of at least 183 days over the current calendar year and the preceding calendar years.

4. Promotion is valid for eligible Cardholders who are not an existing customer of Union Power at the time of sign up and do not have a Union Power account that was terminated or closed (whether by the individual or by Union Power) in the last twelve (12) months prior to the commencement of the Promotion Period.
5. The Gift will be credited by Union Power to Eligible Cardholder's Union Power account and used to offset the Eligible Cardholder's third Union Power electricity bill ("Electricity Bill"). If the Electricity Bill amounts to less than the value of the Gift, the remaining value will be used to offset the subsequent Electricity Bill(s) until it is fully utilized.
6. The Gift given under this promotion is not exchangeable for cash or any other products or services unless stated otherwise by Union Power and cannot be used in conjunction with other promotional codes, discount, or vouchers, unless otherwise stated.

¹ 12-months Union Power Plan refers to "Union Saver 12" and "Power Saver 12".

² 18-months Union Power Plan refers to "Union Saver 18".

³ 24-months Union Power Plan refers to "Union Saver 24", "Union Saver 24 (LPG)" and "Power Saver 24".

7. The Gift shall be credited to the Eligible Cardholder's Union Power electricity account by 31 December 2020. An Eligible Cardholder who refunds, cancels or disputes the recurring bill arrangement and Union Power Plan before he/she receives the Gift will forfeit the Gift.
8. The Gift credited under this Promotion (i) cannot be used to offset against any minimum payment due under the Citi Credit Card account and (ii) cannot be withdrawn from the Citi Credit Card account in cash.
9. Full and prompt payment in all monthly bills before disbursement of rebate. In the event of contract breach or early termination before supply end date stated in the contract, Union Power reserves the right to recover promotion value.
10. Citibank's and/or Union Power's decision on all matters relating to the Promotion will be determined in its reasonable discretion and is final and binding on all participants.
